Applications differ depending on the profession and the method of applying, including examination, endorsement from another state or acceptance of an examination taken in another state.

Broker Examination You must register with PSI/AMP as a student prior to your course completion, and your course completion information must be received electronically from your school to complete the examination registration process.

Your Examination

The Illinois Real Estate Exam contains 150 multiple-choice questions. 105 of these questions are national questions and 45 are state questions. You'll have 3 ½ hours to complete the test, and a score of 75% is required to pass (results are provided immediately upon completion).

Most states administer the tests in two parts, and require that the candidate pass both.
